Food fraud and EMA are intentional acts designed to evade detection. Therefore, food fraud is deterministic in nature, and cannot be adequately addressed with probabilistic food safety risk assessment frameworks.

Most food fraud cases are not harmful, but notable exceptions include the melamine in Chinese skimmed milk powder (Gossner and others 2009), sudan dyes in spices (Stiborova and others 2002), false labeling of puffer fish

as monkfish (Cohen and others 2009), and the plasticizer di (2-ethylhexyl)phthalate (DEHP) being used as a cheaper substitute of clouding agents in food and beverages (Yang and others 2013).
