Mobile notaries can charge travel fees along with the standard notary fees if they have to go somewhere to get papers signed, but some states limit the maximum travel fee. In many cases those limits are low, but in all cases the cost must be "reasonable." In most cases, the notary public and the signer should agree on travel fees before a meeting to sign papers takes place.

How Much Do Notary Fees Cost? - The Balance

If a notary public is a party to a transaction, or has a direct or indirect financial (or other beneficial) interest in the transaction, no matter how small, the notary must decline the notarization. To avoid the appearance of bias and preserve the integrity of the notarization, have a totally disinterested third party notarize the document.

To obtain licensure in New York, Registered Nurses are required to take a nursing exam known as the National Council for Licensure Exam-RN (NCLEX-RN) which ensures the candidate is prepared for entry level nursing practice.
